

## **INFORMATION ON DATA PROCESSING PURSUANT TO ART. 13 EU REGULATION 2016/679**

This information is provided to those who undergo the oro-pharyngeal/rhino-pharyngeal swab carried out at Vismederì S.r.l.

Kind patient, pursuant to art. 13 of EU Regulation 2016/679 (hereinafter "GDPR" or "Regulation"), laying down provisions for the protection of individuals regarding the processing of personal data, we want to inform you that your Personal Data will be processed in compliance with the above mentioned legislation and the confidentiality obligations to which Vismederì S.r.l is bound. Your data will be processed in accordance with the principles of correctness, lawfulness and transparency.

### **DATA CONTROLLER**

We inform you that, pursuant to art. 13 of EU Regulation 2016/679 (hereinafter "GDPR"), your personal data are processed by Vismederì S.r.l., Data Controller, (hereinafter also "Data Controller"), in the person of its legal representative pro tempore Dr. Duccio Meiattini, with registered offices and headquarters located at address Strada del Petriccio e Belriguardo n.35, 53100 Siena, Italy. ### **CATEGORIES AND OTHER TYPES OF DATA RELATED TO THE TREATMENT**

The Data Controller will process your general and your personal data (that means the data that can reveal racial or ethnic origin, political opinions, religious or philosophical beliefs, or trade union membership, as well as the genetic data, biometric data aimed to identify a specific person, data related to the health or sexual life or sexual orientation of the person), by referring to the activity that may be exercised within society as related to the prevention service, care, diagnosis and rehabilitation requested by the subject and in particular the execution of the oro-pharyngeal/rhino-pharyngeal swab.

### **PURPOSE, LEGAL BASIS AND TREATMENT SCOPE**

Your Personal Data will be treated for the following purposes:

- a) Prevention, treatment, diagnosis and rehabilitation purposes and administrative-accounting activities strictly related to the management concerning relations with the patient (acceptance, booking, etc.). The personal data processing carried out for the pursuit of the purposes referred to in lett. a) is carried out on the basis of art. 6.2.b), 9.2.h) and 9.3 of the GDPR, as necessary to provide the required healthcare.
- b) In compliance with the law obligations, regulations and Community legislation (particularly in the field of health and hygiene, tax compliance, administrative checks, inspections of health surveillance teams, investigations by the judicial police, etc.). Concerning the legal basis related to the treatment see Articles. 6.1.c); 9.2.g); 9.2.h); 9.2.i) of the GDPR.
- c) Defensive purposes. The legal basis of the treatment is referred to in Articles. 6.1.f) and 9.2.f) of the GDPR.



The use of the requested data concerning the purposes indicated above, including administrative ones strictly related to these, is highly necessary; If the data are not provided will be impossible to accede to the requested service.

In addition, the Personal Data will be processed by the Data Controller only if you authorize for the following purposes: the report will be sent to the email address you indicated (service of "online reporting"). The legal basis concerning the treatment if you authorize it, pursuant to Art. 9.2.a) of the GDPR.

The granting of consent is necessary for sending the report electronically by email. The lack of consent, or the revocation of the same - which may take place at any time pursuant to art. 7 GDPR-, will preclude the use of the above mentioned service but it not impact on its request for the swab execution addressed to Vismederì. In this case the report will be sent by ordinary mail to the address you indicated.

### **RECIPIENTS AND TRANSFER OF PERSONAL DATA**

Personal Data may be shared with:

- identified personnel, authorized to process personal data and specifically instructed in accordance with art. 29 of the Regulation and 2-quaterdecies of D. Lgs. 196/2003 ("Privacy Code");
- service providers (such as consultants, institutions, etc.), who typically act as data controllers pursuant to Art. 28 of the GDPR; - people, institutions or authorities to whom it is mandatory to communicate your Personal Data pursuant to legal provisions or orders issued by competent authorities.

The complete and updated list of data recipients may be requested from the Data Controller, at the dedicated addresses indicated above.

### **TRANSFER OF EXTRA EEA DATA**

The Data Controller does not transfer your Personal Data outside the European Economic Area.

### **RETENTION OF PERSONAL DATA**

Your Personal Data will be stored only for the time necessary for the purposes for which they are collected, respecting the principle of minimization referred to in Article 5, paragraph 1, letter c) of the GDPR. The Data Controller may retain certain data even after the termination of the contractual relationship, for the due time related to contractual and legal requirements. More information is available at the Data Controller or at the DPO at the contact details indicated above.

### **DATA USE**

Concerning the indicated purposes, the use of personal data takes place through manual, computer and telematic tools strictly related to the purposes themselves and, in any case, with methods that ensure the security and confidentiality regarding the data, and compliant with specific legal obligations.

### **PRIVACY RIGHTS**

You have the right to *accede to your* data anytime, pursuant to art. 15-22 GDPR. In particular, you may request the rectification, cancellation, limitation concerning the data use in the cases mentioned by art. 18 of the GDPR, the revocation of consent, to keep your data unchanged in the cases provided for by art. 20 of the GDPR. You can make a request to withdraw you approval to process your data pursuant to art. 21 of the GDPR explaining the reasons justifying the opposition; the Data Controller will evaluate the right to assess your request, which may not be accepted if there would be the lawful reasons to proceed with the data use that prevail over your interests, rights and freedoms. You can also withdraw your consent to use the service of sending the report to your email address at any time. Written requests must be addressed to the Data Controller or to the DPO at the contact details indicated and specified above. If you believe that the use of your personal data carried out by the Data Controller violates the GDPR, you can complain addressing your request to the Data Protection Authority, as provided by art. 77 of the GDPR itself, or to refer to the appropriate courts pursuant to art. 79 of the GDPR.





## INFORMATION ON SWAB TEST FOR RESEARCH AND QUANTIFICATION ABOUT SARS-COV-2 RNA

The oro-pharyngeal/rhino-pharyngeal (nasal) swab sample is a procedure concerning the superficial cells extraction of the mucosa located in the posterior pharynx and on the rhino-pharynx, with a small stick of synthetic material that can retain organic material. The sampling has minimal invasiveness, causing, at most, a nuisance when touching the point of contact. The swab is subjected to the viral RNA extraction procedure which will subsequently be quantified by an amplification method known as "PCR (Polymerase Chain Reaction)". The molecular swab test is a diagnostic test for detecting the presence of the virus at a precise moment, very useful, for example, to detect a contagious person in order to isolate him immediately at home for preventing the viruses spread (core of small outbreaks). The virus presence in the respiratory mucous membranes is a sign of replicative activity, therefore the person is contagious and must be subjected to home quarantine informing his general physician and the competent Health Authorities.
